2025 Residential Energy Optimization Rebate Registration Form for Existing Homes



Valid for Eversource or United Illuminating (UI) ("Companies") residential electric service customers ("Customer") who purchase and install a qualifying air source heat pump* ("Equipment") for an existing home on or after January 1, 2025, through December 31, 2025. Air Source Heat Pump Rebate Registrations ("Application") with required documentation must be postmarked no later than February 28, 2026. Equipment must be ENERGY STAR® Cold Climate certified and installed by a contractor participating in the Energize CT Heat Pump Installer Network. It must replace natural gas, oil, propane or electric resistance as the primary heating source. If replacing an existing heat pump, adding heating to a previously unconditioned space or using the heat pump solely for cooling, please complete the 2025 Residential Air Source Heat Pump Rebate Registration Form for Existing Homes, available at Energize CT.com/ashp. Projects are randomly selected for inspection. Refusing a post installation inspection could result in forfeiting your rebate. Please note Customer must submit this form along with the required documents by mail or online before

*A heat pump is an electrical system, unless you currently have electric resistance heating, it will add to your electricity usage. In many cases, that additional electric use is offset by savings elsewhere, such as a propane or oil heating fuel bill. You may decide that increased comfort is worth an additional energy cost. Adding a heat pump where there was no cooling source before will increase your electric use in the cooling source.

ELIGIBILITY: Incentives are available to Eversource or United Illuminating (UI) ("Companies") residential electric service customers ("Customer"). Equipment must be installed by a contractor participating in the Energize Connecticut^{5M} Heat Pump Installer Network. If an existing boiler or furnace will be left in place, a qualified integrated control must be installed for heating zones where propane, oil or natural gas will remain in use. Eligible homes include existing single family and 1–4 unit multifamily structures. Please be sure to verify your model(s) at: EnergizeCT.com/HPQPL

Equipment Requirements: Air source heat pumps and integrated controls must be listed on the Energize Connecticut Heat Pump Qualified Product List. Refer to Energize CT.com/HPQPL

Rebate Form: This Application must be filled out completely, truthfully, and accurately. The Customer must date and submit the completed Application along with all required documentation for specific rebates and/or incentives. By submitting the rebate Application, the Customer agrees to abide by these Terms and Conditions. Program is subject to change without prior notice, including rebates and incentive levels.

Time Limit: Qualifying Equipment must be purchased and installed between January 1, 2025, and December 31, 2025. Rebate forms must be postmarked by February 28, 2026.

Payments: From the time the rebate Application is processed and approved, please allow 90 days for payment. Payment processing will take longer if information or documentation is missing. Please contact Resource Innovations at 888-855-0282 to inquire about the status of your Application.

Installation must be completed by a participating Energize CT Heat Pump Installer Network Contractor to be eligible for rebates. This rebate is only available to residences that are occupied full time during the winter heating season. This rebate may not be combined with any other utility or energy efficiency service provider offer for the same equipment. Rebate amount not to exceed the cost of the total equipment and installation and may be subject to change without notice.

Proof of Purchase: A copy of the Customer's invoice itemizing the purchased Equipment must accompany each rebate Application. The invoice must indicate the Equipment make and model numbers, installation date and address, total install cost, and proof of payment.
