

## Instant Incentive Programs

## How does the instant incentive program work?

Instant incentives or midstream incentives are point of sale incentives available for contractors and customers through dealers & distributors.

### Upstream = Incentives through Manufacturing

Midstream (Instant Incentives) = Incentives through Distribution

Downstream (Express Incentives) = Incentives paid directly to the customer or contractor

## Program Rules & Reminders

**Instant Incentive Programs** 



Only municipal, commercial, and industrial customers serviced by Eversource, CNG, SCG, or UI.



Customers are only eligible for one incentive pathway (i.e. customers receiving whole building incentives are NOT eligible)



Equipment must be purchased through a participating distributor or dealer



Equipment must program meet minimum efficiency requirements or be on the specified qualified product list (QPL)

#### **Program Rules & Reminders for Instant Incentive Programs**



Equipment must be installed within 30 days



Pre-approval may be required, please consult with your distributor or dealer



Projects are subject to inspection



Product cannot be sold at no cost






#### **Controls**

#### Currently:

- Controls make up 17% of our savings for midstream lighting
- <1% of C&I customers have advanced controls
- 1/3 of customers are interested in controls in the future
- Cost & training appear to be the primary barrier to the adoption of controls

### Impacts of the Energy Independence & Security Act (EISA)

#### What is EISA?

EISA is a federal act focused on energy savings. It includes the goal of limiting the sale of general service lamps to a minimum of 45 lumens/ watt, effectively requiring the sale of all screw-based, downlight, and tracking lighting product in the country be LED. As a result, we would no longer have claimable savings on screw-based lamps. 

#### **Overview of 2023 Changes**

- Removal of boiler and furnace instant discounts (incentives will continue to be available through the Express program for specific installation types)
- Updated efficiency requirements for air source heat pumps and air conditioners
- Additional energy optimization heat pump rebates for fuel-switching projects



requirements for heat pumps < 5.4 tons updated to align with the **new federal standards** 



Any models that meet the 2022 criteria will be considered eligible for installation through December 31, 2023
